I have the honour to report that today i.e. 17/01/2024 at about 7:10 pm, while I along with SI Md. Bharul and police team were on mobile patrolling along Alia Lamkhai road one TVS NTORQ scooter bearing Regn. No. Nil and one Honda Activa white in colour bearing Regn. No. Nil were seen coming from Lilong Bazar side towards Alia Lamkhai road and on seeing us, the unknown persons who were riding the two wheeler scooters ran away leaving behind the two wheeler motors. No. Nil and Honda Activa white in colour bearing Regn. No. Nil at 7:20 pm of 17/1/2024 from the possession of Md. Amir Khan (24) S/O (L) Md. Suleiman of Lilong Haoreibi Turel Ahanbi Ubakthong Makha by preparing formal seizure memo and he was arrested from the spot at 7:25 pm of 17/1/2024 by preparing a formal arrest memo for being a vehicle lifter.

It is therefore the arrested person along with the seized two wheeler scooters is handed over to you to take up further necessary legal action.
