Sir,

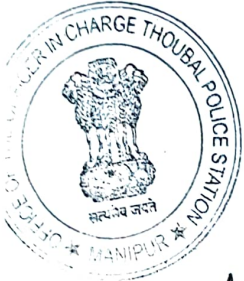
