Subject : Report.

Sir,

On 17-01-2024 at around 1830 hrs a sudden violent mob consisting of more than 1000 people stormed the 3<sup>rd</sup> India Reserve Battalion Headquarter located at Khangabok, Thoubal District with an intension to loot arms and ammunition. The mob surrounded the Battalion Headquarter and forcefully entered from 1<sup>st</sup> Gate after breaking it. The intruders broke all the doors of the Office of the Adjutant Branch, Q.M. Branch, Barracks etc. and also tear official files after breaking the Iron Godrej (Almirah). The mob tried to stormed the Quarter Guard. Seeing the violent nature of the mob the personnel of the unit along with Quarter Guard Sentry (BSF) at Battalion Headquarter dispersed the mob outside the gate by firing 10 (ten) rounds and Tear Gas in the air and bring the situation under control. No casualty on both sides is reported.

It is also reported that a Motorola Hand Held Set bearing SI.No. 037TLNC702 ID :1662 PW:1111 of CDO/Thoubal who came for reinforcement was found missing.

It is therefore requested to take up necessary legal action against the miscreants.
