

Sir

I have the honour to state that today i.e. on 30/12/2023 at about 1130 hrs, received a reliable information that some unknown miscreants have stored and hidden some arms, ammunition and explosives etc. at Lilong Nungei Taibang Palli inter village road.

On received of this information, Special Operation Group (SOG), Thoubal District Police along with a column of 33 AR, C. Coy Lilong Post and a team of Lilong PS led by Addl.SP(Ops)/TBL assisted by OC/CDO-TBL under the overall supervision of Sr. SP/Thoubal rushed towards the said location and launched a massive operation at 1230 hrs. On searching the area, the following items i.e. (1) 01 no. of Stun Gun. (2) 01 no. of modified .303Rifle (3) 03 nos. of Stun Shell. (4) 02 nos. of Tear Smoke Shell Soft Nose. (5) 01(one) no. of Tear Smoke Shell Chilli (6) 01 no. of Tear Smoke Shell Normal (7)) 01 no. of Smoke Grenade WP (8) 01 no. of Stun Grenade (9) 02 no. of Chinese Grenade (10) 02 nos. of Hand Grenade No. 36 (11) 02 nos. of Hand Grenade No. 90 (12)) 01 no. of Wireless Set Baofeng (13)) 01 no. of Wireless Set Motorola (14)) 01 no. of Magazine of .303LMG (15)) 02 nos. of Magazine of Carbine. (16) 03 nos. of ammunition of .303 rifle (17) 05 nos. ammunition of AK rifle (18) 01 no. of Bullet Proof Plate and (19) 01 no. of Bullet Proof Jacket were recovered from the bushes near IVR road adjoining to a paddy field at Lilong Nungei Khongbal suspected to be hidden by the unknown miscreants.

The said recovered items have been seized from the spot at 1345 hours pm by observing formalities.

It is therefore, handed over the seized items to you for further necessary action.
