



Sir,

I have the honour to report that in the intervening night of 22/12/2023 & 23/12/2023 two nos. of my oxen have been lost from my Cow shed located at Lilong Nungei Ching. In the morning of today i.e. 30/12/2023 one Md. Nawaj Sarif @ Kot Amu aged about 25 yrs. S/O. Md. Sarafbuddin of Thoubal Moijing were detained and enquired about the matter of lost oxen at the premises of Md. Islamuddin . Later, he commented that the above noted oxen had been stolen by me along with Md. Achouba 26 yrs. S/O. Md. Khomei of Lilong Dam Makha Basir Salam & Md. Nawaj Sarif 23 yrs. S/O. -do- of -do-. and it's had already sent in a DI Tata to Lilong Bazar for wrongfull selling. On the other hand, I including Md. Nahapik of Lilong Chingjao along with my some localities were proceeded at the house Md. Achouba & Md. Nawaj Sarif located at Lilong Dam Makha Basir Salam to enquire the matter. Suddenly 05 (five) individual namely 1) Md. Khomei 58 yrs. S/O. Md. Iboton of Lilong Dam Makha Basir Salam, 2) Md. Aja Khan 30 yrs. S/O. -do- of -do-, 3) Md. Achouba 26 yrs. S/O -do- of -do-, 4) Md. Sadam 25 yrs. S/O. -do- of -do- & 5) Md. Nawaj Sarif 23 yrs. S/O. -do- of -do-. had assaulted me and Md. Nahapik of Lilong Chingjao by holding sticks, knife & daws. As a result, one Md. Nahapik got blunt injury at her forehead and other parts of his body and one Bolero Car bearing Regd. No. MN04A-6468 white in colour also received partly damaged and it's broken by the above culprits.

I therefore request you to take up necessary actions against the culprits.
