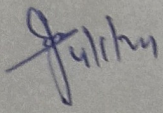

I, the undersigned, C. Lalrammawi Thiek age 63 years D/o H.T Thangkhum, who is a victim and presently taking relief/shelter at Mizoram have the honour to state the following for your kind intervention and favourable action that on 25th October, 2023 at around 8:30 p.m night, Unknown Mob with pick up truck from the Meitei community went to my shop called 'Lucy Store' Shop No. IW50 which is under Imphal Municipal Council at Paona Bazar was forcefully looted/robbed all the valuable goods inside the store and destroyed all the showcase and furniture. Particulars of properties looted and destroyed.

- (1) Immovable property - RCC Building, Pucca Shop
- (2) Movable property - All the garments, shoes, ladies bag and wedding accessories.

that all the estimated value of both the looted and destroyed properties to be worth approximately Rs. 3,05,54,000 (Three crore five lakh fifty four thousand only).

I, C. Lalrammawi filing the report at the nearest Police station and therefore request you to kindly take necessary legal action against the said culprits as per law.
