That, the complainant and Langpoklakpam Nanda Singh, S/o Langpoklakpam Mayangamba Singh of Tekcham Bazar are the recorded pattadars and owners of the homestead land (Residential 2<sup>nd</sup> Class) measuring 0.00223 hectare under Patta No. 89/40 (old), 1374/1658 (new) covered by C.S. Dag No. XVII/120/481/562 of village No. 87 (A) –Khwai Bazar, District: Imphal West, Sub- Division- Lamphel Central, Tehsil- Lamphel Central, Unit – A-1, Manipur, situated at Kakhulong Paona Bazar, Imphal West District, Manipur along with one storied pucca structure standing thereon.

3. That, the ground floor of the said building is let out on lease which is now running a variety shop by the lessee and the 1<sup>st</sup> floor is kept vacant for further construction.

4. That, the complainant and the above said co-pattadar used to visit the said homestead land from time to time and occasionally. Recently on 19-01-2023 at about 8.00 a.m. when the complainant visited there the above accused persons have been found to be occupying the 1<sup>st</sup> floor of the said building without permission from his co-pattadar and him. Then the complainant asked them to leave the place and keep the room vacant but they refused to do so. Immediately the complainant informed the matter to his co-pattadar and he also asked them to leave the room but they pay no heed. Further, the accused persons and their men and agents threatened the complainant and his co-pattadar that they would killed them if they again asked them to vacate the room.

5. That the accused persons have committed offences of house trespass and criminal intimidation with common intention and as such the accused persons are liable to be punished under the law.

6. That, the complainant reported the matter to the Officer-in-Charge City Police Station and Superintendent of Police Imphal West on 21-01-2023 and 31-01-2023 respectively but no FIR case or proceeding has been taken up till date.



It is therefore prayed that Your Honour be pleased to give direction to the Officer-in-Charge of City Police Station to investigate the case and take up an FIR case against the accused under Sections 448, 506 and 34 of IPC for the offence they have committed for the ends of justice.
