

Subject: - Report.



Sir,

I have the honour to state that today i.e. 15/01/2024 at about 03:30 pm, received a reliable information about the presence of some active cadres of PREPAK (VC) an outlawed banned organization in and around Paona Bazar area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meitei, OC-CDO-IW, and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW, rushed to the said area and conducted cordon and search operation near Usha Cinema Hall, Paona Bazar. During that two unknown persons were found standing near Usha Cinema Hall in a very suspicious manner. Due to their suspicious nature, they were detained for spot verification and checking.

On spot verification they identified themselves as :- (i) Nonthombam Manao Singh (27) S/o. N. Kiran Singh of Haoreibi Mayai Leikai, Imphal West District. On preliminary verification, he disclosed that he is an active member of PREPAK (VC) organisation and joined the said organisation in the month of October, 2023 and presently working under the command of s/s Revenue Officer Pritam @Angousana @Meitei (Ph. No. 9402079637) of PREPAK (VC) organisation. On spot body search, one wallet black in colour containing one Aadhaar Card and one Voter ID Card, were recovered from his possession. Hence, he was arrested at the spot at 04:10 pm and the above mentioned recovered articles were seized at 04:15 pm by observing formalities and (ii) Nongmeikapam Inao Meitei (27) S/o. (L) Nk. Sunil Meitei of Haoreibi Awang Leikai, Imphal West District. On preliminary verification, he disclosed that he is an active member of PREPAK (VC) organisation and joined the said organisation in the month of October, 2023 and presently working under the command of s/s Revenue Officer Pritam @Angousana @Meitei (Ph. No. 9402079637) of PREPAK (VC) organisation. On spot body search, one Samsung Galaxy M31 S mobile handset along with one Airtel SIM card bearing SIM number 8991160990010492212U (Ph. No. 8974377668 as disclosed by him), one wallet brown in colour containing one Aadhaar Card and a sum of Rs. 6,500/- (Rupees six thousand and five hundred only), were recovered from his possession. Hence, he was arrested at the spot at 04:20 pm and the above mentioned recovered articles were seized at 04:25 pm by observing formalities.

On further verification, they disclosed that under the instruction their commander, they came to make monetary demand to the mobile shop located at the Imphal area.

It is, therefore, the arrested persons and seized articles are handed over to you for taking further necessary legal action against them.
