

As per endorsement, I have conducted an enquiry in c/w a written report filed by one Dilip Wahengbam aged about 56 years S/O (L) W. Ibohal Singh of Khagempalli Panthak, Imphal West where he stated that on 07/01/2024 early morning they found that some unidentified person came and stole their belongings i.e gold jewellery and money amounting about 15 tolas of gold and 1 lac money.

On enquiry, it was found that some unknown person have entered inside their living room and have stolen some gold ornaments amounting about 15 tolas and a sum of money Rs 1,00,000/- (one lakh only). On 07/01/2024 at @ 10.00 AM, the spot was inspected very carefully and minutely with the assistance of Finger Print Bureau, Imphal Manipur.
