Sub: Report of property burnt by Mob

Sir,

I am Ngamboi Vaiphei Baite (33 yrs) s/o Thothang Baite, a resident of N. Terakhong village, P.S. Lamlai, Island block, Kangpokpi District. On the 4th of May 2023, some unknown miscreants in the form of a mob came and burnt down our village and all our property including my "concrete interlocking block" making plant (small industry) at N. Terakhong. I had machinery, raw materials and concrete blocks in the industry location, the details of which are as follows:

1	Machinery	30lakhs
2	Tata (MN03T 0012)	15lakhs
3	Raw materials (including cement and others)	2lakhs
4	Concrete blocks (20,000 pieces) @ ₹28 per block	5.6lakhs
5	Plant and office setup (including entire Industry set up, water tanks, office furniture and desktop and other accessories)	15lakhs
6	Land cost	40lakhs

Total: ₹1.076Crores

The name of the concrete block plant (small industry) is registered as "Alpha concretes" and is registered under MSME (UDYOG AADHAR) under government of India. As the entire plant has been vandalised and destroyed and all the blocks also stolen by unknown persons, I would like you to kindly do the needful and lodge a complaint according to the relevant sections of the IPC
