



Sir,

With due respect, I have the honour to state the following few lines for your kind perusal and to take up further necessary legal action.

That, one M. Kartik, aged about 29 years, S/o Muniya Sami of 62 Annai Sivagami Nagar 2<sup>nd</sup> Street, Ennore Chennai Kaltivakam, Tiruvallur, Endore Thernal Station, Tamil Nadu, presently residing at the 1<sup>st</sup> Floor, Hotel Daani Continental situated at Thangmeiband Meisnam Leikai who is the Proprietor of Imphal Kangla Cab Service, Manipur had taken my vehicle, Bolero B6 bearing Regn. No. Nil (A/F) having Engine No. TVN6F46850 & Chassis No. MA1XK2TVXN5F42549 for using his cab service on 04/12/2023 with a condition to pay a sum of Rs. 50,000/- per month as hiring charge however, he failed to pay the monthly hiring charge. Moreover, it is learnt that he has mortgaged my vehicle to an unknown person and the whereabouts of my vehicle is still not known. He has now absconded from his present residence and office. Vigorous efforts have been made to trace him out but in vain. Thus, he has cheated me and misappropriated my vehicle for his wrongful gain only. The handing taking of my vehicle was made at the premise of Daani Continental, Thangmeiband Meisnam Leikai.

It is therefore, requested kindly to recover my vehicle and take up necessary legal action against him as per law.
