I am the Chief of N. Heikon Village being village Touzi No. 59 of Island Sub-Division, Kangpokpi District & Census code No. MMDS 2011, Code No. 269046.

That, On the afternoon of 3rd and 4th of May, 2023, around 8 AM, miscreants suspected to Meitei community, who were instigated and abated by the Meitei Leepun & Arambai Tenggol of Valley based CSO's had carried out an attack on me and my village namely "N. Heikon" of Island Sub-Division, Kangpokpi District, Manipur.

That, Due to such attack and being in the state of vulnerability, fearing to lose our life. I along with my villagers had fled from our village. As such, Mr. Ngampao Lhungdim aged about 60 years S/o Sothang Lhungdim was killed by them. Upon inquiry, I came to know that 39 household of the village including Church, School, Anganwadi centre and community hall were ransacked, looted and burnt down to ground. Properties were looted and taken away; domestic animals were killed leaving the village at helm.

Therefore, render us to a state of homelessness. Members of villagers are scattered and displaced in different places.

I, therefore, seek to your kind office to register a complaint (Zero-FIR) against the perpetrator and abettor, who had carried out such heinous attack against me and my villagers.

Looking forward with your anticipation, I shall always remain grateful to you.
