





Today i.e. 20/01/2024 at @ 02.00 PM, I came across in social media a viral message transmitted from one phone number 9233591488 where he wrote that " Room da AC tharaga leibado nungybane", " Namai mathu twribo hwjik fwba kasubi macha lmc cro net thingbada nggi nupi dagi hwna family tumna htkani skthu ng namaido ekydro ckhrona skthu kasubi macha biren namai mathu madarchod lmao lwra biren nupi do khra ymmna lonnaga leiyo besha " . The viral whatsapp message directly threatens the life of Hon'ble CM of Manipur and his family members. Moreover, transmitting such threat message at this juncture of crisis in Manipur provokes the general public and is likely to disturb the maintenance of harmony, public order and public tranquillity in the state. Circulating the said viral message may also induce any section of public to commit an offence against the state or against the public tranquillity.

Hence, a suo-mottu case under FIR No. 21(01)2024 IPS U/s 153-A/307/505(2)/506 IPC has been registered for investigation.
