

Today i.e. 22/01/2024 at @ 02.00 PM, I came across in social media a viral message transmitted in various social media that all the unit of Arambai Tengol from unit 1 to unit 54 must prepare for any eventuality and they warn all the Meitei MLAs of both ruling and opposition including Ministers and Hon'ble Chief Minister to come at Kangla Utra to discuss about the prevailing situation of Manipur. If all the Meitei MLAs of both ruling and opposition including Ministers and Hon'ble Chief Minister fail to turn up, they will be treated as enemy of the state and they also warn to take stern action if they fail to turn up. The viral message directly threatens the life of Hon'ble CM of Manipur and Meitei MLAs of both ruling and opposition. Moreover, transmitting such threat message at this juncture of crisis in Manipur provokes the general public and is likely to disturb the maintenance of harmony, public order and public tranquillity in the state. Circulating the said viral message may also induce any section of public to commit an offence against the state or against the public tranquillity.

Hence, a suo-mottu case under FIR No. 23(01)2024 IPS U/s 120-B/153-B/505(2)/506 IPC has been registered for investigation.
