

FIRST INFORMATION REPORT

1. On 24 January 2024, at approximately 9.30 PM, a group of 12 unknown armed miscreants attired in black/OG dress, with their face masked with Scarf entered, NCC Group HQ Imphal Complex. Six of the miscreants were seen carrying Pistols, Revolver and Double Barrel Gun. They woke up all NCC Instructors and gathered them at one place and took their mobile phone to prevent them from communicating and recording the incident. They, then asked where weapons are kept. On informing them that no weapons is held with NCC, they then specifically asked for .22 Rifles. On denying that any weapons is held with NCC Bn, they insisted on checking one Store Room of 14 Manipur Bn NCC. They broke open the door(Photograph attached as Appendix) and searched the Store Room. On not finding any weapons, they started looking for other stores. They took six Steel Helmets and six Magazine Pouches with them. Thereafter, they returned the mobiles back to the NCC Instructors and left the complex at 10.15 PM.

2. The following items were taken along:-

- (a) 06 x Steel Helmets
- (b) 06 x Magazine Pouches
