

Subject: Criminal trespass upon our property by Ningombam Manirotan Singh

Sir,

Last night at around 9p.m (26.01.2024), Shri Ningombam Manirotan Singh aged about 56 years of age S/o (L) N. Manao Singh, a resident of Moirangkhom Makha Loklaobung, Imphal West district, came on the passage way of my residence which is in our possession and urinated in front of me and my sister Hiyaileima Thokchom to insult and annoy us.

He also intimidated us that he will urinate everyday in front of our residence and if any member of my family objects then he or she will be chopped off with a machette. He also claims that he will urinate from his terrace on our residence premises.

A video clip of him urinating in front of my sister is recorded by my sister herself and submitted to Manipur Police facebook inbox as well as Whatsapp.

In this regard, it is requested to take appropriate legal action against Shri Ningombam Mani Singh for committing criminal trespass on our property.
