

Subject: - Complaint for taking up necessary legal action against Pauboi Kuki Zo @pbkhuptong under Section 107, 121, 121-A IPC for criminal activities against the State.

Occurrence: - In the month of January 2024 and the same has been acknowledge by the Complainant within the jurisdiction of this Police Station on 27.1.2024.

Sir,

The Complainant as a law-abiding citizen of India, is extremely concern about security and integrity of the State.

The State of Manipur is now reeling under a State of uncertainty because of frequent and continuous attack by armed Kuki-Zo militants/ miscreants. Many innocent people lost their lives because of the current violence initiated by Kuki Narco terrorists since 3<sup>rd</sup> May, 2023. Many are rendered homeless and taking shelter in relief camps.

It is now clear that the reason for initiating and continuing this violence by the armed Kuki militants/ miscreants is to turn their dream for a separate Kukiland/ Zalongam into a reality. In other words, they are waging a war against the State to meet their objective.

In this violence torn State, it is upload in X (formerly twitter) by the accused person which is reproduced as hereunder: -

*"The day SoO is abrogated will be the day when 700 sq km will be ablaze. It will starts from all corners, and within a day or two, Imphal will be finished. Remember, you are surrounded by #Kuki\_Zo.*

Even now, without our trained army but only with Village volunteers, you cannot penetrate #Kuki\_Zo villages.

If SoO is abrogated, they will take their arms and emerge to annihilate 700 sq km. We will suffer too, but Manipur will be under @Kuki\_Zo rule.

Beware, our SoO cadre is highly trained; one person can handle 15-20 enemies.

About 3000-5000 SoO cadres will lead 50,000 village volunteers from all corners of 700 sq km.

Then Imphal will succumb within a day or two.

Be careful Meitei. ...."

As evident, the accused has committed the offence under Section 107, 121 and 121-A of IPC and preventive measure is to be taken against him under the preventive detention law as his threat is of serious nature and he also abets his community and Kuki Militants under SoO to wage war against the State of Manipur and the Country.

In the circumstances, you are requested for taking immediate necessary action against the accused person in accordance with law.


