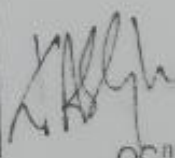

Sir,

With due respect, I have the honour to state that today i.e. 29-01-2024 at around 4.30 PM while my son namely Ngairangbam Dohenba (11) yrs. S/o Ng. Roshan Singh of Nagamapai Kangjubi Machin, P.O & P.S - Imphal, Imphal West District was playing with his friends at Kangjubi Lampak, he was physically assaulted with an intent to kill him by one individual namely Lairenlakpam Motilal Singh (53 yrs.) of Nagamapai Kangjubi, P.O & P.S-Imphal, Imphal West District at Kangjubi Lampak by using cane stick without any reason. As a result of which he has received serious injuries on his person and immediately he was evacuated to State Hospital for medical treatment where the concerned Doctor opined that his left hand got fractured.

It is therefore, requested your good self to kindly take up necessary legal action against the said Lairenlakpam Motilal Singh (53 yrs.) of Nagamapai Kangjubi at the earliest.
