Subject: Request to file a First Information Report (FIR) against Mr. Olive Jajo for misappropriate of Government funds.

Respected Sir,

Clover Organic Private Limited is a private company committed to supporting farmers across India. It's Head Office is located at Dehradun and Branch Offices are in Mizoram, Manipur, Meghalaya, UP and Andhra Pradesh and has been working in Manipur since 2017.

To address the challenges faced by farmers like lack of market access & credit linkages, inadequate financial support and lack of managerial skill etc. the Department of Agriculture, Cooperation & Farmers Welfare (DAC&FW) under the Ministry of Agriculture and Farmers' Welfare (MoA&FW) has formulated the central sector scheme Formation and Promotion of 10000 Farmer Producer Organization (FPO) for implementation across the country. Clover has been allocated 9 Blocks under Kangpokpi District to establish 9 Farmer Producer Companies (FPC) by the Implementing Agency North Eastern Regional Agricultural Marketing Corporation Ltd. (NERAMAC).

Under Island block of Kangpokpi District, Ngarum Island Area Farmer Producer Company Limited was registered under the Companies Act on 29th April 2023. Mr. Olive Jajo from Thangjingpokpi Village of Island Block, Kangpokpi was selected as Board of Director cum Chairman of the company. For the functioning of the Farmer Producer Company (FPC), the Ministry of Agriculture and Farmers' Welfare (MoA&FW) sanctioned a management cost of Rs. 3,95,000/- in the Ngarum Island Area FPC account, Deulah Land on 13th October 2023. The signatories of the company are Mr. Olive Jajo and Mr. Marvin from Risophung village, Islan block, Kangpokpi district.

It came to light that when the company was asked to submit their updated Bank statement, Olive Jajo withdrew Rs. 2,98,200 (Two lakh ninety-eight thousand and two hundred only) on different dates. As chairman of the FPC, this violates his fiduciary duty as there are very strict guidelines for the withdrawal of the cash and we believe that he has withdrawn the funds for personal use. He was oriented regarding the restriction of cash withdrawal even before the funds were received. Despite this, the cash withdrawal was done at Punjab and Sind Bank, located at Deulah land, Imphal. The details are as follows:

We the staff of the FPCs and board of Directors verbally and in writing have asked Mr. Olive Jajo to deposit the withdrawal amount several times. In spite of promising several times, he never meets his promise and also avoids his phone calls. The fear is that he has the company cheque book with him.

Therefore, I, Mr. Sanjay Kumar, the Vice President of Clover Organic Private Limited condemn the misappropriation of funds given for the upliftment of the farmers and have finally decided to file a FIR against Mr. Olive Jajo for the misappropriation of the funds of the Government. Mr. Marvin should also give a proper explanation for blank cheque signature to withdraw the amount. We humbly request that the police investigate this and take the necessary action to help us recover these missing funds.
