That, I owned a 4-storey pueca building, registered in my name Mrs. Lhingneikim Kipgen W/o John Manglianthang Zou, located at House No.1. Zomi Villa, Kabo Leikai, opposite Independent Church, Imphal East District, Manipur.

That, due to the communal clash that broke out from 3rd May, 2023, we had abandoned our residence for our safety leaving behind all properties and get evacuated to a safer place.

However, we have received information from our neighbours that on 03-06-2023 at around 5:00 p.m., unknown miscreants broke opened the gate and trespassed into our premises. In the process, they took away all valuable properties apart from vandalizing of immovable properties.

It is, therefore, requested to kindly take prompt action and ensure protection of the premises and properties from further damage.

Cause of delay in reporting on time is due to my displacement and lack of legal knowledge.
