I have the honour to state that, with the sudden outbreak of communal conflict between in Manipur on 3rd May 2023, some unknown miscreants belonging to Meitei community started hunting the Kuki settlers in the Imphal valley. That, I occupied At Grace Girls Boarding Dewlahland Imphal East District about 40 Km South from Saikul –PS, and the violent mob numbering in thousand deliberately attacked the Kuki inmates at Dewlahland Area. Fearing lost of life and to avoid any circumstances from the enraged mob I fled for my life to a nearby safe location and leaving behind all my belonging, studies materials, clothes and essential items. Fortunately I survived the attacked and was transported to Kangpokpi District by Central Security force.

Further, It is learnt that, on 25-08-2023 at around 09:00 pm some unknown miscreant suspected to be belonging to Meitei community vandalised and broked into my room and burnt down all my belonging to ashes.

The list of properties destroyed or loss are mentioned in the Annexure(enclosed). The Approximate value of lost properties is calculated at about Rs. 70,500/- (Seventy thousand and five hundred).

Due to lack of legal knowledge and some personnel problems I could not report in time.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
