

Sir,

With due respect, I have the honour to state the following few lines before you for your kind consideration and necessary action.

That, on 4th May 2023, due to the recent violence in Imphal and adjoining areas, I have left my house, household properties and locality to my safety place by locking all my doors and gate.

However, it has come to my knowledge that, miscreants belonging to Arambai Tenggol have encroached upon my house by marking AT at my gate. Then, the miscreants belonging to Arambai Tenggol on dated 17th January, 2024 at around 11:00 have illegally occupied and settle at my house. The miscreants have also looted my household properties like Furniture, Kitchen and Utensil items, Electronic gadgets, Clothing and Garments and other valuable items. The Total amount of looted properties are estimated at Rs. 8,00,000/- (Rupees Eight lakhs) only.

The incident could not be reported to my concern PS timely due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action in this regard.
