

That due to the ongoing conflict between Kuki and Meitei, I am compelled to leave  
the above mention Houses at Old Lambulane Jail Road, Imphal West, on the 8<sup>th</sup> May 2023.

That, on the 12<sup>th</sup> June, 2023 at around 8:00 pm, received an information that my belongings  
which I have left behind were all looted and plundered by unknow miscreants.

The approximate value of properties looted were estimated to be about Rs 14,20,000/-  
(fourteen lakh Twenty thousand) only

So, I therefore request your good officer to kindly take up necessary legal action in  
this regard.
