

Sir,

With respect and honour I have the honour to state the following few lines for your kind consideration and necessary action.

That, on the 4<sup>th</sup> of May, 2023, I have left my house, House No. 22 and household properties for my safety by locking the doors of the house and gate due to the ethnic violence at Imphal and at the adjoining areas.

And that, from the 22<sup>th</sup> of December, 2023 a person by the name Rani Gangmai and her family stayed at the mentioned house as a homestead resident. However, on the 20<sup>th</sup> of January 2024, Meitei armed miscreants, Arambai Tenggol approached the house and enquired the aforementioned homestead resident as to whether rent was being paid for their stay in the house. When the resident answered negative, the armed miscreants threatened them to leave the house unless they pay the house rent to them.

It may be mentioned that the total cost of the house is approximately Rs. 20,00,000 (Rupees Twenty Lakhs).

I, therefore request you to take appropriate actions accordingly.
