



SUB –Submission of a report in c/w a threat viral voice message surfaced in various Social Media.

Sir,

I have the honour to state that today i.e. 02/02/2024 at @ 10.00 AM, I came across in social media a threat viral voice message surfaced in various social media. The viral voice message is reproduced as follows- "All people, if we have to stop the current violence in Manipur everyone should stop helping in the relief camps. So, that all the inmates will start agitation against the Manipur Government and another large scale violence like June 18 will happen. Everyone has to join the agitation/violence without fearing death. Assembly should be burnt down and all government establishments should be vandalized and burnt down including the residence of Chief Minister of Manipur and MLAs. India Government is planning for destroying Manipur State and why should we be under the Government of India. There are lots of enemies for Meiteis. Every Meitei should not be silent spectator just because that their family is not affected. If the Meitei's tackle the situation in a right way this is a big opportunity for us. Instead of facing the war by common people the state Government must face the war. Instead common people are contributing money and facing the war. The violence is due to the ignorance of the common people. The state government instead of facing it they form many small groups to fight in the war. Knowingly or unknowingly we supported the government without any reason directly or indirectly. The violence like June 18 is inevitable in order to stop the present crisis of Manipur or do we have to wait to get killed one person from each household. We celebrate after killing one another. These are all plan of Government of India to destroy our economy. The boundaries are shield by the army. Their plan is to capture every Meitei's including those who reside outside the state. This is the right time to revolt large scale violence like June 18 to stop

the crisis to save the Meitei's. Otherwise, Meitei are doomed to be finished. We have to sacrifice for our motherland, we should not fear death.

The viral message directly instigates and provokes the public to rise up for a large scale violence against the government of India and Manipur. Besides, it threatens all govt offices, employees as well as the Hon'ble CM of Manipur and MLAs of both ruling and opposition. Moreover, transmitting such threat message at this juncture of crisis in Manipur provokes the general public and is likely to disturb the maintenance of harmony, public order and public tranquillity in the state. Circulating the said viral message may also induce any section of public to commit an offence against the state or against the public tranquillity.

It is therefore requested kindly to initiate further necessary action.
