unknown miscreants.

Sir,

With due respect, I would like to state the following for your kind information and
necessary action:

That, due to the on-going conflict, we were compelled to flee our home located at
Dewlahland, KCC, PO Imphal East, PS Porompat, Imphal East District, Manipur.

Unfortunately, it is also learnt from a reliable source that all my household properties
were ransacked, plundered and looted by Meitei miscreants belonging to Arambai Tenggol,
Meitei Leepun, assisted by Meitei communities from the nearby localities.

The total cost of properties lost, including all household items, and many other valuable
properties is estimated to be about Rs. 12,00,000 (Rupees Twelve Lakhs)

In this regard, I would like to request your good office to take up necessary action so
that I can be compensated, the culprits be caught and stringent exemplary punishment be meted
upon them.
