

Sir,

With reference to the above subject, I have the honour to report that my residential building (House No. 49, Sl. No. 283) standing at Canaan Veng, North AOC Imphal East – 795001, Wangkhei Assembly Constituency, Manipur was looted on 18th October, 2023 by some unknown miscreants from Meitei Community. The looted properties includes Furnitures, Almirahs, Utensils, Blankets, Electronic devices etc.

Now, we learnt from a reliable source on 23rd December, 2023 that the unknown miscreants from Meitei Community locked the house with an intention to occupy as their own house. This is against the standing order of the State Order No. 3608/2/2023-HD-HD Dated the 10th October, But we have no any alternative means except to submit this affidavit and further report you to link my affidavit to the JIC (Judicial Inquiry Commission) set up by the Ministry of Home Affairs, Govt of India under the Chairmanship of Shri Ajai Lamba, Chief Justice (Rtd.) of the Gauhati High Court's notice, Dt. 20/11/23 and its deadline notice of 24/01/24.

In this regard, I requested your kind esteem office to take up necessary legal action.
