



Sir,

I have the honour to state that I am going to marry one Kennedy Newmai (21 yrs) S/O Heuchiliang Newmai of Mandu, Tousem, Sub-Division, Tamenglong in the month of January 2023. We were living in a rented room at Wahengbam Leikai since April, 2022. We both lived on the said rented room and had intimate relationship with full consent. However, on 21/12/2023 at about 01:30 pm, one Joyson who is cousin brother of Kennedy Newmai had sent me a video of intimate relationship between me and Kennedy at the rented room at Wahengbam Leikai and informed me that it goes viral.

It is pertinent to mention that there are only 3 rooms adjacent to each other. And only 2 (two) rooms were occupied. One of the room was occupied by me and Kennedy and other room was occupied by (1) Khundrakpam Tomthinganba (24) yrs S/o Kh. Ramesh Singh of Yairipok Thingel Thoubal, 2) Thangjam Thoiba Singh (24) yrs S/o (L) Th. Bolai Singh of Ukhongshang Mayai Leikai and 3) Moirangthem Jeetchandra Singh (49) yrs S/o (L) M. Modhumangol Singh of Nongpok Sekmai Engourok. There is no other occupant in the said rented room. The above-mentioned persons were goldsmiths and always present at the rented room which is next to our room. The viral video could only be a captured and shared by the above-mentioned persons.

It is therefore, requested to kindly find out the above mention culprits and to take up necessary legal action at the earliest.
