



Sub:-Humble request for taking up appropriate action against Haoneo Hangmi and etc for causing promoting enmity between different groups on grounds of religion, race, place of birth, residence, language, caste, community or any other group any aggravated form of insult to religion and also when it is perpetrated with the deliberate and malicious intention of outraging the religious feelings of that class any person and for outraging modesty to different caste/race of Manipur.

Dear Sir/s,

With due respect I the undersigned have the honour to submit a few things for your kind perusal and necessary action:

1. I am a humble citizen of India having a resident of Uripok Khoisnam Leikai, P.O & P.S Imphal, District Imphal West, Manipur.
2. On 25/12/2023, I came across upon my facebook account and I saw the post of one, Mo Nie as "SAVAGE REPLY" and then one, Haoneo Hangmi has replied to the greetings of Christmas given by our Chief Minister of Manipur "as *Shakthu merry Christmas wish tourak kanu, church mayam meithadokraga merry Christmas kaina Nato kak kanī*".
3. This uploaded reply of Haoneo Hangmi is not his fundamental right to speech and expression. His statement is chilled with a threat of reprisal. He has a malicious intent and mens-rea to outrage religious beliefs and feelings; the posts has to be judged from the standard of a reasonable and strong-minded person and at best the words exhibit carelessness with deliberate and malicious intent. His word is an act of insult to or attempt to insult the religion or the religious beliefs of a class of citizens but it penalises with varieties of attempts to insult the religion or the religious beliefs of a class of citizens, which are perpetrated with the deliberate and malicious intention of outraging the religious feelings of that class..." His speech is made with 'malicious intent' and not 'offensive speech' and it is an aggravated form of insult to religion with deliberate and malicious





intent to outrage the religious feelings of the group is punishable. Written words etc. that bring the State into contempt or hatred or create disaffection fall within the ambit of the penal statute when the feeling of disloyalty to the government established by law or enmity to it imports the idea of tendency to public disorder by use of actual violence or incitement to violence. Being promotion of feeling of enmity, hatred or ill-will 'between different' religious or racial or linguistic or regional groups or castes or communities, involvement of at least two groups or communities is an act for creating enmity, hatred or ill-will between classes and an intentional insult with intent to provoke breach of the peace and it is also an act of deliberate/malicious acts intended to outrage religious feelings of any class by insulting the religion or religion beliefs and he has tried to promote enmity between the classes of people and it is an hate speech and he has defamed our Chief Minister by alleging and inciting general public and blackening the face of our C.M of Manipur with a malicious intention to cause disorder or incite the people to violence.

Hence, I am praying Your Goodself to take appropriate action against the above named person.
