Today i.e. 28/12/2023 at 05.00 pm, found one clarification note on a letter head of the Sunusiphal Ideal Club, Sunusiphal, Regd. No. 997 of 1972, BPO Phuballa, P.O. & P.S. - Moirang, Bishnupur District, Manipur under Ref. No. 31/12/2023 dated 25/12/2023 in the social media published by one W. Ratankumar Singh, General Secretary, Sunusiphal Ideal Club, Sunusiphal clarifying that the villagers of Sunusiphal were shocked and alarmed on seeing a news column in the Kangleipakki Meira News Service, edition of 24th December, 2023 in the 2nd column of 2nd page reporting that the Kuki militants started attacking again by firing five rounds to the Sunusiphal village on 23/12/2023 at 06.00 pm. The Secretary further stated that there is a peaceful life in Sunusiphal village, and such an alarming and misleading report by the editor, Kangleipakki Meira should not be done instead the editor must publish true and real news to the public.

On enquiry, the said news is found published in the daily evening newspaper "Kangleipakki Meira" on 24th December, 2023 in the 2nd column of 2nd page, and such false and alarming news spreads in the midst of the crisis mislead the different communities which promotes hatred, enmity, revenge and retaliation at this juncture where the restoration of peace is being started between the different communities.

It has been also found that this daily evening newspaper has been publishing instigating and unverified news items which create panic among general public and also gave opportunity to miscreants to disturb peaceful environment and public order.

Hence, a suo-mottu case under FIR No. 903(12)2023 IPS u/s 153/153-A/505(1)(b)/505(2) IPC has been registered against the Editor of "Kangleipakki Meira" (daily evening newspaper) for investigation.
