Subject: - Request for lodging of FIR case regarding looting and Destroy of my house located at Kanto, Prem Nagar Leimakhong Imphal West.

Sir,

I, the undersigned have the honour to state that large number of unidentified groups of people belonging to kuki community with deadly weapons including sophisticated arms suspected kuki militants groups stormed to all Meitei inhabited areas in the state from 3rd day of May, 2023 onward.

1. Regarding the ethnic violence, on 4th May 2023, I along with my whole family members had fled away from my house due to fear & safety of life and taking shelter at Knato Awang Leikai relief camp. Later on shifted to Mandop Yumpham relief camp.
2. However in the first week of September 2023 one of my Nepali neighbour namely Mohan Pal informed me that my house was destroyed and looted my heart earned assets by unknown armed miscreants suspected to be kuki militants. The approximated value of the vandalized and looted is estimated about Rs. 8,97,000/- (Rupees eight lakhs ninety seven thousand) approx.
3. Regarding the matter, I couldn't report timely to your good office due to lack of legal knowledge.

It is therefore, requested you to kindly take up necessary legal action against the above mentioned unknown armed miscreants.

Thanking you to your act of kindness.

I shall be grateful for your kind co-operation and necessary actions.
