On enquiry it is reveals that on 21/12/2023 at @ 7:30 pm some unknown arm persons came to the house of one Premkumar Chinghsbam (45) S/o (L) Ch. Yaima Singh of Awang Leikinthabi Awang Leikai land no. 7 and destructed some decorative items including Christmas Star which are decorated in c/w the upcoming Christmas festival. Later, the unknown arms persons assault the said Premkumar Chinghsbam while he was attending a meeting at Awang Leikinthabi community hall and also damage plastic chair and some other material of the Community Hall. As a result of which Premkumar Chinghsbam sustained injured on his person and undergoing treatment at Raj Medicity.

As per the enquiry so far conducted has pointed for a thorough investigation by drawing a regular FIR. Hence, I am Submitting this report for kind necessary action.
