Sir,

With due respect, I have the honour to report the following few lines that, I am resided at rented house located at Leimakhong Chingmang which was run by one Yangleikhup Vaiphei of Leimakhong Misi Houbi since 2 years back and I have run one Tailoring shop at Leimakhong Chingmang, IW district, Which is adjoining to Kuki villages.

On 04/05/2023 at around 12:30 pm some unknown person suspected to be Kuki militants and Kuki rioters opened fire towards Meitei populace area of Leimakhong Chingmang, IW district and torched/ vandalized many houses of Meitei Community. In that, I along with my family members have come out from the above rented house and taking shelter at Relief Camp, Nungoo Primary School, Kakching District by keeping my house under locked and Key. On 30/11/2023 it comes to light that, the Kuki arms militant and Kuki rioters had trespass my shop and looted my belonging properties by breaking the Lock and key which I had locked. The approximate value of properties are estimated at Rs.4,00,000/- (Rs. Four lakh) approximately.

Regarding the matters I couldn't able to report till date due to the present situation in the states and lack of Legal Knowledge. Hence, I therefore reported to your good office for further procedure.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
