Sir,

With due respect, I have the honour to report the following few lines that, I am resided at rented house located at Kanglatongbi Shantipur which was owned by one Wahengbam Sunil Singh of Kanglatongbi Shantipur since January 2023, which is adjoining to Kuki villages. Due to the ongoing communal crisis between two communities. On 3rd May, 2023 at around 4:10 pm, I along with my family members have fled away from the rented house by keeping my rented house under locked and key. The owner of the rented house namely Wahengbam Sunil Singh informed through telephonic that on the same day at around 7:30 pm suspected to be Kuki militants and rioters had trespass my rented house and totally burnt down all the valuable house hold all items i.e. furniture items, Kitchen items, clothing, electronic items and some workshop tools. The approximate value of the properties that were burnt down in about Rs. 65,000/- (Sixty five thousand only).

Regarding the matter I couldn't report timely due to the lack of legal knowledge. It is therefore, requested to kindly look into the matter and take up necessary legal action.
