

No-AR-01-L-2158, Chassis No-HAR3DXSUC02716181, Engine No-H00200666, Yellow in Colour, Amounting of Rs. 20,00,000/- (Rupees Twenty-Lakhs) only ; & (ii) JCB-JS 205 LC Excavator being Machine No-2240021, Engine No-84387320 & Chassis No-PUNJD20BJH2240021, Amounting of Rs. 25,00,000/- (Rupees Twenty-Five Lakhs) only with the transport charge, were also burnt/damage by the unknown miscreants during this situation of the Kuki-Meitei Rivalry w.e.f 3<sup>rd</sup> May, 2023 while parked at or in between Lungthulian to Purvachan under Tipaimukh Block (i.e. Road site near work site) Churachandpur.

By the way, the Complainant could not proceed any complaint/report in the place of in between Lungthulian to Purvachan under Tipaimukh Block, Churachandpur, during this present situation of Manipur, Sir.


