With due respect, I have the honour to report the following few lines that, I am resided at rented house located at Leimakhong Chingmang which was run by one Nongthonbam Brajamani of Leimakhong Chingmang since 1 years and 3 months back, which is adjoining to Kuki villages. Due to the ongoing communal crisis between two communities. On 3<sup>rd</sup> May, 2023 at around 9:45 pm, I along with my family members have come out from the rented house by keeping my rented house under locked and key. On i.e. 31/12/2023, it comes to light that, suspected to be kuki arms militants and kuki rioters had trespass my rented house and looted my belonging properties i.e. 2 TV, Refrigerator, Inverter, washing Machine, 3 Cylinder, 3 Bed, 2 Almirah, Misc, Jewelers (Bangles 1 pair, Righ 2), Bank Passbook, cheque, Book Aadhar Card including me and my wife namely Wangkhem Pishakmachan Chanu HSLC Mark Sheet and certificate, 12 Mark Sheet and certificate, Graduate Mark sheet, M. Phil Mark Sheet, Faculty Induction Programme (Guru Daksha), Seminar and conference Certificates, Sport Achievements Certificates, Misc. The approximate value of properties are estimated at Rs. 5,50,000/- (Rs. Five lakh and fifty thousand only) approximately.

It is therefore, requested you to kindly look into the matter and take up necessary action at the earliest.
