Subject: - Report.



Sir,

I have the honour to state that yesterday i.e. 25/01/2024, an information was received that at about 10:40pm some gun shots were heard at road in front of PWD office, Khoyathong. Immediately, teams of CDO-IW led by Inspector P. Achouba Meitei OC-CDO-IW, Inspector Gunachandra Chanam and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and started to chase a suspected white color Bolero going towards Khongnang Ani Karak side. The above Bolero was chased and stopped by the above teams near Lamlong Bridge and overpowered the occupants immediately.

On checking the said white Bolero with registration no MN01AW8948, one driver and five occupants were found and they were detained for spot verification and checking. During frisking, one 9mm pistol (RUGER P89) with 1 magazine loaded with 3 live rounds (bearing body no 310-38680) was found concealed in one black shoulder holster under the left arm of one person who identified himself as Sairem Saxena Meitei (34yrs) @ Athoiba s/o S. Arunkumar Meitei of Khurai Puthiba Leikai. He further disclosed that he is a s/s Lieutenant of UNLF, an outlawed organization. He also said that he had got basic military training near Mithit (Myanmar) under 34th batch (1st group) in 2007 and have army no. 2227. He is currently working under the command of s/s Major Ibudhou of UNLF who is the organisation secretary of Imphal West District. He further disclosed that his commander s/s Major Ibudhou works under the command of s/s Major Salam Nongdol who is the Organisation Secretary of UNLF organisation. He also disclosed that he fired some rounds in front of PWD office Khoyathong and some more rounds at North AOC from the above 9mm pistol. On further body search, the following articles were recovered from his possession – i) one NokiaTA-1575 phone alongwith one Airtel Sim bearing SIM Card no 8991166990023262417U (phone no 8730045470 as disclosed by him), ii)one Nokia phone TA-1575 along with one Airtel Sim bearing SIM Card no8991160990021663364U (phone no 8132949497 as disclosed by him), iii) one MI10i phone along with one Airtel Sim bearing SIM Card no 8991000905266074865U (phone no 7302360180 as disclosed by him) and one Jio Sim bearing SIM Card no 89918700400378280772 (phone no 7409201614 as disclosed by him) and iii) one black wallet containing one PAN card bearing no DBJPM3480F.

On further verification and body search, the other occupants identified themselves as below and following articles were found from them as under.

1. Pukhrambam Muhiraj Meitei (26yrs) s/o P. Sunilkumar Meitei of Sagolband Tera Pukhrambam Leirak and at present Uyumpok Wakhong who is the driver of the above white Bolero. One MI11X phone along with one Jio SIM card no 89918650400099607436 (phone no 7005119641 as disclosed by him) was recovered from his possession.
2. Ngasam Sunil Singh (44yrs) s/o Ng. Kumar Singh of Khurai Chingangbam Leikai. One Redmi Note 12 5G phone along with one Airtel SIM card no 8991160990014032101U (phone no 9774162166 as disclosed by him) was recovered from his possession.
3. Tharoijam Jiban Meitei (44yrs) s/o Th. Irabot Meitei of Tharoijam Mamang Leikai. One iPhone 13 along with one Airtel SIM card no 8991160990017843763U (Phone no 7627925669 as disclosed by him) was recovered from his possession.
4. Yangoijam Nongmailemba Meitei (25yrs) s/o Y. Santa Meitei of Heingang Makha Leikai who is the owner of the above Bolero. One Galaxy A23 5G phone along with one Airtel SIM card no 8991160990022904334U (Phone no 8131976077 as disclosed by him) and one Jio SIM card no

89918650400117794265 (Phone no 7005345687 as disclosed by him) was recovered from his possession.

5. Khangembam Manojkumar Singh (45yrs) s/o Kh. Ibomcha Singh of Khurai Chingangbam Leikai. One Redmi Note7 Pro phone along with one Airtel SIM card no 8991160990023427394U (Phone no 8131046818 as disclosed by him) and One Plus Nord CE3 Lite 5G phone along with one Jio SIM card no 89918650400115371355 (Phone no 8787630442 as disclosed by him)

Therefore, i) Sairem Saxena was arrested from the spot at 10:50 pm and the above recovered articles from his possession were seized at 10:52 pm by observing formalities, ii) Pukhrambam Muhiraj Meitei was arrested from the spot at 11:00 pm and the above recovered articles from his possession were seized at 11:03 pm by observing formalities, iii) Ngasam Sunil Singh was arrested from the spot at 11:10 pm and the above recovered articles from his possession were seized at 11:15 pm by observing formalities, iv) Tharoijam Jiban Meitei was arrested from the spot at 11:17 pm and the above recovered articles from his possession were seized at 11:25 pm by observing formalities, v) Yangoijam Nongmailemba Meitei was arrested from the spot at 11:30 pm and the above recovered articles along with the above mentioned white Bolero from his possession were seized at 11:35 pm by observing formalities and vi) Khangembam Manojkumar Singh was arrested at 11:40pm and the above recovered articles from his possession were seized at 11:45 pm by observing formalities.

Hence, the arrested persons along with the seized articles are handed over to you for taking further necessary legal action against them.
