Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

- 1. That, I Smt. Tinneithem Haokip W/o Robert Letkhomang Haokip, belonging to the Any Kuki tribe/community, a Schedule Tribe recognized under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.
- 2. That, I Smt. Tinneithem Haokip W/o Robert Letkhomang Haokip is an allotee of government residential quarter of D157 Zone III situated at National Game Village, Imphal West P.O & P.S. Lamphel.
- 3. That, on the 4th of May 2023 I was attacked by a group of armed Meetei/Meitei radicals spearheaded by Meetei Leepun and Arambai Tengol aided by valley based State Forces. These criminal broke open the gate and looted, vandalized and burnt/gutted all what is within my quarter comprising of all my household items/assets are lost due to the said incident, a total lost estimated to be at an amount of Rs 9,00,000 was all lost.

Fortunately, me and my family managed to escaped from these criminals and survive the ordeal who even tried to kill or burn us alive, and now currently taking refuge at Churachandpur.

In the given circumstances, I humbly pray you to kindly register an FIR, and investigate into the matter and punish the perpetrators as per the prevailing provisions/ laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
