Subject - Report on crimes of attempt to murder, vandalism, looting of properties and discrimination of Scheduled Tribes.

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

- 1. That, I am a Scheduled Tribe belonging to the *Zou Tribe*, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.
- 2. That, due to the prevailing ethnic crisis in and around Imphal, I along with my family left our rented house located at Phainua Veng, National Game Village, P.O./.P.S.- Lamphelpat, District- Imphal West- 795004 on the 3rd of May, 2023 at around 4:30:00 AM, it has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tengol and Meetei Leepun on the 4th of May, 2023 at around 11:00AM.
- 3. That, the criminals broke open my door, destroyed and looted everything including our educational certificates and other important documents. The total evaluation of properties looted/destroyed from my house/ premise is worth about Rs.30,68,000 /- (Rupees Thirty Lakhs Sixty-Eight Thousand) only.
- 4. That, it may be reported here that the miscreants were shouting slogans like"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were
 carrying out their criminal activities. It seems to me that all these has taken place at the instance
 of the Manipur State Government as the perpetrators openly claimed and shouted that nobody
 would stop them, even the police because everyone, including top officials of the Manipur
 Government are patronizing them and that that no harm could be done to them.

I, therefore, request you to kindly register my case as **ZERO FIR** and take stern action against the perpetrators under the relevant provisions of the law of our country.
