That I Thangtuozing aged about 51 years W/o Lalpienghun Belonging to the Hmar Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989, and that I am a resident of Langol Housing Complex Type III Near Meirasang PO/PS Lamphel -795004
- 2. That at about 3 pm on the 3th may 2023, a huge contingent of armed radical meeitei/Meitei suspected to be members of the Arambai Tengol and Meetei Leepun numbering about 2000 attacked our locality and in the process, they have looted my house.
- 3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge loss which may be estimated to be Rs. 8110000 (Rupees Eighty One Lakhs Ten Thousand) only
- 4. Fortunately, me and my family managed to escaped from the criminals who even tried to even kill us, and
- 5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled atKolasip Mizoram

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.
