AM/ PM, a huge contingent of armed radical Meitei/ Meetei, Arambai lengel, Neutei Leepumalong with the Manipur State forces like the Manipur Police Commando, the Indian Reserved Battalion (IRB) attacked our village and in the process, they have looted, vandalized and torched my house on the 03rd May, 2023.
 - That, it may be reported here that the miscreants were shouting slogans like-3. "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.
