Sub:- Complaint regarding burning down of my building at Moreh, Tengnoupal District.

Sir,

With due respect, I am to lodge a complaint that my 3-storey pucca building at Moreh Heinoumakhong, Ward no. 7 (near District Hospital, Moreh), Moreh Town, Tengnoupal District was burnt down completely on the night of 4th May, 2023 and afternoon of 28th May, 2023 by the Kukis in the recent communal clash w.e.f. 3/5/2023. In fact, all the Meitei houses/ buildings at Moreh have been destroyed by the Kukis. The schedule of my land (patta copy enclosed for reference) on which the building was built is shown below:

The building itself would cost around 1.50 crores (Rupees One crore and fifty lakhs only) as it was a 3-storey pucca building. It was constructed mainly with materials taken from Imphal with 5 (five) rooms on each floor and a common garage on the ground floor. Each room was provided with 2 (two) bulbs and a fan and each floor was again provided with water supply pumped from an underground water reservoir to the rooftop tanks. The rooms were provided with separate electric meters and sub-meters for the convenience of the inmates. The rooms were given out on rent when the incident occurred.

It is therefore requested kindly to take up necessary action at the earliest.
