covered by C.S. Pag No. 1041/2008 (A) measuring an
area of 0.265 acres situated at Revenue
Village No. 91 - Meitei Kangol, Imphal - West District
along with an Indian Passport which belong
to my daughter-in-law namely DOUNGOL NENGHOE
& HAKIP pass bearing passport no. R2184698.

I hereby request you to kind take action in the
regard immediately.
