I am to state that, on 5th August 2023, our locality Hebron Veng, Phaipijang Largol, under Lamphel Police Station, Imphal West District was under mob attacked by hundreds or thousands of unknown miscreants belonging to the Meitei community with criminal intention to cause damage of property and life.

As a result, many houses and properties were looted, destroyed and burnt. Among which my house was also looted, destroyed and burnt by the Meitei mob.

List of properties (both immovable & movable) looted, destroyed and burnt are given

- A. Immovable assets/properties: Double storey building (Concrete and Wooden mixed structure) with top roof of GI sheets (green colour) Tiles floor with Modular kitchen and standard bathroom both Indian and Western toilets.
- B. Movable assets/properties:
  - 1. Gold & Jewellery: Gold chain 50gm 24 carats, pair of Gold Bangles 50gm &Ear rings 22gm.
  - 2. Granary & Grains: 3 bags of rice, 1 bag of dal & 1 bag of potatoes.
  - 3. Documents: School/College/degrees/Aadhaar/PAN/Birth Certificates, Family Documents, Albums, Family Gov't related documents, Mementos, Citation & various kinds of books.
  - 4. Vehicles: 1 Yamaha Rx 100, 1 Maruti Omni Van & 2 bicycle.
  - 5. Furniture: 2 Computer table, 3 Godrej Steel Almirah, 2 Sofa set, 2 TeakwoodDressing table, 5 Sleeping beds, 2 Kitchen Cupboard, 1 Dining Table.
  - 6. Traditional Ornaments: 20+ Traditional ornaments.
  - 7. Modern & Traditional garments: 68 pieces of shawls, 17+pieces of traditional attires/garments & 100+ modern garments.
  - 8. Cooking Fuel: 2 Gas book, 6 Gas Cylinder, 1 Gas stove,
  - 9. Electronics Items:Double Decker Whirlpool Refrigerator, Sony Bravia HD TV 83 cm, Sony Home theatre sound system, 2 sets of PC with 2 HP 3045 printer & HP scanner, Hair Washing machine 10kg, Videocon washing machine 8kg, Solar Plate with solar fans, Inverter with batteries, Generator, 1 laptop, 2 mobile handsets, 2
