

Sir, I have the honour to report that on 4th May 2023 at 1:00 pm, a group of Meitei Organisation more than 300 in nos. suspected to be Arambai Tenggol, Kangleipak Kanba Lup, Meitei Leepua attacked my quarter D/115, Zone-I, at National Games Village, looted and vandalised all my properties worth Rs. 16,50,000 approximately. They also attacked my vehicle Maruti Alto LX(10) bearing Regd. No. MN01AG7568/26th Feb, 2020 between National Games Village Zone-II and CRPF camp, Lamphel while we are rusting for a safety zone i.e CRPF camp, Lamphel and burnt down to ashes.

Therefore, I request you to kindly lodge an FIR in connection with the incident.
