In inviting a reference to the above cited subject, I have the honour to report that on 4^{th} May ,2023 due to communal violence spread across Imphal valley towards the Kuki-Zo tribe by some radical sections of the majority valley based organization, my colony Springvilla, Phaipijaang, Langol located at Imphal West have been at the receiving end of most inhuman activities by the radical mob. At around 11 pm on 4th May,2023, Meitei mobs attacked the colony numbering in thousands with various arms including sophisticated rifles which have also resulted in the loss of life and many injuries at my colony.

Since, the incident was very sudden, we had no time to pack anything including important documents and valuable items nor could we file an FIR at police station earlier. In the process they have looted all valuable items including cash, documents and jewellery, later they destroyed and burnt down the properties including various items in and around the home compound. In this regard, I am to request you to kindly take up further necessary legal actions against those miscreants involved in property theft, destruction and attempt on life as per the law.
