Subject :- Report on Looting of household items/assets

Madam/Sir

With reference to the above cited subject I have the honour to report to you as follows :

1. That I **Seiminthang Kipgen** aged about 34 years S/o **Paosei Kipgen** Belonging to the Any-Kuki Tribe / Community, a schedule Tribe recognized under the constitution of India , by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a permanent resident of **Langol Housing Complex Type III E-30 ,PO/P S., Lamphel Imphal West.**
2. That at about **6 am** on the **4th May 2023**, a huge contingent of armed radical meeitei/Meitei suspected to be members of the **Arambai Tengol and Meetei Leepun** along Meitei mob attacked our Quarter at Langol Housing Complex and so, me and my family have to run for our lives and in the process, they have looted my house along with some Cash and some Jewelleries (gold).
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred a huge loss which may be estimated to be **Rs. 1850000 (Rupees Eighteen lakhs fifty thousand) only**
4. Fortunately, me and my family managed to escaped from the criminals who even tried to even kill us, and took shelter Grace Academy school Tuibong churachandpur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at My relative place at Grace Academy School Tuibong Churachandpur. And ,thus I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an **FIR/ZERO FIR** , investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And , for which act of kindness, I shall always remain thankful to you and obliged.
