I, Immanuel Hringurkhum Sanate age about 23 year s/o Robinson Sanate belonging to Hmar Scheduled Tribe a residence of Type -iv Quarter No. 4 AIR Colony, Lamphel P.O.&P.S. Lamphel Imphal West was a Medical Student staying at Room No. 245, Gents' Hostel No.2 Regional Institute of Medical Science, Lamphelpat Imphal-795004 have to leave my hostel after leaving behind my belongings in the hostel on the 3rd day of May 2023 at around 9:00pm because of the onslaught on Kuki-Zo Community by the majority Meitei Community who came and search tribal students belonging to Kuki-Zo community and thereby locking our hostel room thus, it became a threat to our life and personal safety.

That, It came to my knowledge on the 14th June 2023 at around 7:00pm that my belonging such as Clothing, Blanket, Laptop, Mobile Phone, study Material etc at a value of about Rs. 95,000/- (Rupees Ninety Five Thousand only) were looted by Meitei miscreant and mention may be made that my Marksheet of MBBS 1st & 2nd year were lost in this unwarranted incident.

Therefore, I would like to pray that your office may kindly initiate necessary action at the earliest for the end of justice.




