With reference to the above cited subject I have the honour to report to you as follows:

1. That I **Robinson Sanate** aged about 62 years S/o(L) **Ngursanglien Sanate** Belonging to the Hmar Tribe / Community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989**, and that I am a Resident of **Type-IV Qrt No. 4 All India Radio Colony, Lamphelpat, Imphal-795004**
2. That at about **4 pm** on the **3<sup>rd</sup> May 2023**, a huge contingent of armed radical meitei/Meitei suspected to be members of the Arambai Tengol and Meitei Leepun and a mob attacked our Quarters at All India Radio Colony Lamphelpat Imphal. so in order to save the lives of my family as well as myself I have to run for my life at the initial days of the attack. And after me and my family left our house they have looted and vandalised our Quarter on **15<sup>th</sup> June 2023**.
3. That, it may be reported here that the above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated to be **Rs. 710200** (Rupees Seven Lakhs Tenthousand and two hundred ) only
4. Fortunately, I managed to escaped from the criminals who even tried to kill us, and now currently taking refuge at Hmarveng Churachandpur.
5. That, I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at Hmarveng Churachandpur. And thus, I am filing the report lately today.

In the given circumstances, I humbly pray you kindly register an FIR/ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged.




