**Subject – Report on crimes of attempt to murder, vandalism, looting of properties and discrimination of Scheduled Tribes.**

Dear Madam,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Gangte** Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**

That, due to the prevailing ethnic crisis in and around Imphal, and during the absence of my family members who were in Kangpokpi district for a Family meet, I left our rented resident owned by **Jiten (6009115243)** located at Type II, Langol, Imphal West, **P.O. & .P.S.- Lamphelpat, District- Imphal West** on the **4<sup>th</sup> of May, 2023** at around **8:15 AM**, I escaped to save myself and took refuge at different places and camps. And it has come to our knowledge that our deserted residence was attacked and looted by a Group of radical Meitei/ Meiteis suspected to be members of Arambai Tenggol and Meitei Leepun on the **12<sup>th</sup> of June, 2023** at around **3:30 PM.**

That, the criminals broke open my door, destroyed and looted everything and the total evaluation of properties looted/ destroyed from my house/ premise is worth about **Rs.32,50,500** **/- (Rupees Thirty-Two Lakhs Fifty Thousand Five Hundred) only.**


